AMENDMENT IN THE NATURE OF A SUBSTITUTE intended to be proposed by Mr. PAUL

Viz:

1 Strike all after the enacting clause and insert the following:

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Right-to-
5 Work Act”.

6 **SEC. 2. AMENDMENTS TO THE NATIONAL LABOR RELATIONS ACT.**

8 (a) RIGHTS OF EMPLOYEES.—Section 7 of the Na-
9 tional Labor Relations Act (29 U.S.C. 157) is amended
10 by striking “except to” and all that follows through “au-
11 thorized in section 8(a)(3)”.

1 (b) UNFAIR LABOR PRACTICES.—Section 8 of the
2 National Labor Relations Act (29 U.S.C. 158) is amend-
3 ed—

4 (1) in subsection (a)(3), by striking “: *Provided,*
5 *That*” and all that follows through “retaining mem-
6 bership”;

7 (2) in subsection (b)—

8 (A) in paragraph (2), by striking “or to
9 discriminate” and all that follows through “re-
10 taining membership”; and

11 (B) in paragraph (5), by striking “covered
12 by an agreement authorized under subsection
13 (a)(3)”;

14 (3) in subsection (f)—

15 (A) by striking clause (2) and redesign-
16 ating clauses (3) and (4) as clauses (2) and
17 (3), respectively; and

18 (B) by striking “*Provided, That* nothing in
19 this subsection shall set aside the final proviso
20 to section 8(a)(3) of this Act: *Provided further,*”
21 and inserting “*Provided,*”.

22 (c) ADDITIONAL CONFORMING AMENDMENTS.—

23 (1) NATIONAL LABOR RELATIONS ACT.—The
24 National Labor Relations Act (29 U.S.C. 151 et
25 seq.) is amended—

1 (A) in section 9 (29 U.S.C. 159), by strik-
2 ing subsection (e);

3 (B) in section 3(b) (29 U.S.C. 153(b)), by
4 striking “or (e)”; and

5 (C) in section 8(f) (29 U.S.C. 158(f)), as
6 amended by subsection (b)(3), by striking “or
7 9(e)”.

8 (2) OTHER LAWS.—Section 453A(a)(2)(B)(ii)
9 of the Social Security Act (42 U.S.C.
10 653a(a)(2)(B)(ii)) is amended by striking “section
11 8(f)(3)” and inserting “section 8(f)(2)”.

12 **SEC. 3. AMENDMENT TO THE RAILWAY LABOR ACT.**

13 Section 2 of the Railway Labor Act (45 U.S.C. 152)
14 is amended—

15 (1) by striking the Eleventh paragraph under
16 the heading for general duties; and

17 (2) by redesignating the Twelfth paragraph
18 under the heading for general duties as the Eleventh
19 paragraph.

20 **SEC. 4. EFFECTIVE DATE.**

21 This Act, and the amendments made by this Act,
22 shall apply to any agreement entered into or renewed after
23 the date of enactment of this Act.
